



# FRC Team 2710 ~ JetStream

## WAIVER, RELEASE, AND HOLD HARMLESS AGREEMENT

1. I acknowledge that participating on a FIRST FRC Robotics team involves certain risks and that injuries, property damage, other harm, or death could occur to me and or others. I accept and voluntarily incur all risks of any injuries, damages, or harm which arise during or result from my participation in the activities of FRC Team 2710 (also known as JetStream), regardless of whether or not caused in whole or in part by the negligence or other fault of the following "Released Parties": JetStream 2710 Inc., FRC Team 2710 team mentors, FRC Team 2710 sponsors, and/or its or their departments, affiliates, employees, directors, officers, agents, or insurers, and their respective heirs, representatives, successors and assigns. This includes any accident occurring at the team's work spaces, meeting places, or at team competitions and/or other events.

I waive all claims against any of the "Released Parties" for any injuries, damages, losses, or claims, whether known or unknown, which arise during or result from my participation in the activities of FRC Team 2710, regardless of whether or not caused in whole or in part by the negligence or other fault of any of the "Released Parties". I release and forever discharge the "Released Parties" from all such injuries, damages, losses and claims.

I agree to indemnify and hold the "Released Parties" harmless from all losses, liabilities, damages, costs, or expenses (including but not limited to reasonable attorneys' fees and other litigation costs and expenses) incurred by any of the "Released Parties" as a result of any claims or suits that I (or anyone claiming by, under, or through me) may bring against any of the "Released Parties" to recover any losses, liabilities, costs, damages, or expenses which arise during or result from my participation in the FRC Team 2710 Robotics, whether or not caused in whole or part by the negligence or other fault of any of the "Released Parties".
4. I have carefully read and reviewed this Waiver, Release and Hold Harmless Agreement. I understand it fully and I execute it voluntarily.
